MICHAEL T. HEWITT, pursuant to 28 U.S.C. § 1746, declares under penalty of perjury as follows:

- 1. I have worked at The City University of New York ("CUNY") since 1994. I submit this declaration in support of Defendants' motion for summary judgment dismissing Plaintiff's remaining claims in this action set forth in Plaintiff's Fourth Amended Complaint.
- 2. Since January 2018, I have held the position of University Executive Director for Labor Hearings and Appeals at CUNY. From May 2004 through December 2017, I was Assistant Vice President and Labor Designee at Brooklyn College (the "College"), one of the senior colleges in the CUNY system.
- 3. As reflected by an email Plaintiff sent me on May 5, 2014 (a copy of which is annexed hereto as Exhibit A), in early May 2014 Plaintiff contacted me about his request to move his personal property from the College's Political Science Department to the offices of the Africana Studies Department that were located down the hall at James Hall. Plaintiff and I arranged for Plaintiff to arrive on May 8, 2014 "to move [his] things," and, at Plaintiff's request, I arranged for Plaintiff to be able to park in the faculty parking lot at the College that day.
 - 4. On May 8, 2014, Plaintiff came to campus and informed me that he wished to move

the boxes of his materials from the Political Science Department on the 3rd floor of James Hall down the hall to an office in the Africana Studies Department. Accordingly, after speaking with Plaintiff and Professor George Cunningham, who was a professor in the Africana Studies Department, on May 8th I, along with another College employee, loaded Plaintiff's property that had been stored in a storage room off the Political Science Department lounge into carts and, in accordance with Plaintiff's request, pushed those carts down the hall and placed them in one of the offices in the Africana Studies Department suite of offices. Copies of my May 8, 2014 email to Karen Gould, who was then the President of the College, regarding the moving of Plaintiff's boxes to one of the offices in the Africana Studies Department, is annexed hereto as Exhibit B.

I declare under penalty of perjury that the foregoing is true and correct.

Paisley's account is overblown. Moreover, this date was worked out with Joe only about a week or so ago and I asked my assistant to arrange parking and to give the department a heads-up about Wilson's coming. If there was a miscommunication on the latter part, I will find out and address it--she is gone for the day.

Joe was never promised movers. I did try to see if I could get him help, but I told him that ultimately it was his responsibility to get his stuff moved. As it turned out, the young man who does the shredding, whom Pam very nicely made available (and whom I did not even know existed prior to this morning), and I loaded and pushed heavy carts several times to get Joe's stuff out of Political Science. It was all done in approximately 45 minutes and without incident. Of course, none of this would have been necessary had the chair not taken it upon himself, contrary to my counsel, to empty Joe Wilson's office in the first place.

And, yes, I told Paisley that I believed the presence of a security officer would only serve to escalate the situation.
